6. The above offers do not include any communication circuits that are required to deliver the television signal between the Company's Video Switch and the customer sites, which are subject to separate commercial arrangements between the Company and the Customer.
7. The prices listed do not cover any satellite capacity, which can be optionally provided by the Company on case-by-case basis.
